Invitation to Bid for the Design and Build of the Regional Office Annex Building and DILG Quirino Provincial Office Building

1. The **Department of the Interior and Local Government, Regional Office 2** through General Appropriations Act Fund 101 FY 2021 intends to apply the sum of *Seven Million Pesos (Php 7,000,000.00)* for the **Design and Build of DILG Quirino Provincial Office Building located in Capitol Compound, Cabbaroguis, Quirino** for Lot I and of *Eight Million Pesos (Php 8,000,000.00)* for the **Design and Build of Regional Office Annex Building located in DILG Regional Office, Regional Government Center, Tuguegarao City, Cagayan** for Lot II with Project Identification Nos. **2021-10-409 and 2021-10-410, respectively**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Department of the Interior and Local Government, Regional Office 2*, now invites bids for the above Procurement Project. Completion of the Works is required *Two Hundred Seventy (270) calendar days*. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from **DILG R2** and inspect the Bidding Documents at the address given below from **8:00 am to 5:00 pm during Monday to Friday**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **October 22, 2021** from **DILG R2, Regional Government Center, Tuguegarao City, Cagayan** and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Ten Thousand Pesos (Php 10,000.00) each for Lot I and Lot II**. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person, by facsimile, or through electronic means*.

6. The **DILG R2** will hold a Pre-Bid Conference¹ on **October 29, 2021 at 1:00 PM** at **DILG R2 Conference Hall, Regional Government Center, Tuguegarao City, Cagayan**, which shall be open to prospective bidders. Bidders who wish to attend physically shall be required to observe health protocols, as follows:
 - Bidders should present an antigen test result valid within 24-hours prior to the pre-bid conference;
 - Only two (2) representative from each bidding agency are allowed in the conference hall;
 - Proper wearing of mask at all times;
 - Proper wearing of face shield at all times; and
 - Observe physical distancing.
7. Bids must be duly received by the BAC Secretariat through manual submission at **DILG R2, Regional Government Center, Tuguegarao City, Cagayan** on or before **November 10, 2021 at 10:00 AM**. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on **November 11, 2021 at 1:00 PM** at **DILG R2, Regional Government Center, Tuguegarao City, Cagayan**. Bids will be opened in the presence of the bidder's representative who chooses to attend the activity. Bidders who wish to attend physically shall be required to observe health protocols, as follows:
 - Bidders should present an antigen test result valid within 24-hours prior to the pre-bid conference;
 - Only two (2) representative from each bidding agency are allowed in the conference hall;
 - Proper wearing of mask at all times;
 - Proper wearing of face shield at all times; and
 - Observe physical distancing.
10. The **DILG R2** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
