Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
- 4. Prospective Bidders may obtain further information from the **Department of the Interior and Local Government Region II** and inspect the Bidding Documents at the address given below from 8:00 in the morning until 5:00 in the afternoon; Monday to Friday.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on 18th day of March, 2021 from the given address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB in the amount stated in the IB No. 2. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person or through electronic mail of deposit slip.

The **Department of the Interior and Local Government Region II** will hold a Pre-Bid Conference on 26th day of March, 2021, 10:00 in the morning at DILG Region II Conference Hall, Regional Government Center, Carig Sur, Tuguegarao City, Cagayan and/or through video conferencing via Zoom Application with meeting details stated in the BDS, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before 7th day of April, 2021 at 10:00 in the morning. Late bids shall not be accepted.
- 8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
- 9. Bid opening shall be on 7th day of April, 2021 at exactly 1:00 in the afternoon at the given address below and/or through video conferencing via Zoom Application with meeting details stated in the BDS. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
